CHARITABLE TRUSTS ORDINANCE, 1994

THE TRUSAN MUSLIM CHARITABLE TRUST DECLARATION, 2021

(Made under section 3)

In exercise of the powers conferred by section 3(1) of the Charitable Trusts Ordinance, 1994 [*Cap. 7*], the Yang di-Pertua Negeri has made the following Declaration:

Citation and commencement

1. This Declaration may be cited as the **Trusan Muslim Charitable Trust Declaration, 2021**, and shall be deemed to have come into force on the 1st day of October, 2021.

Declaration of Charitable Trust

2. It is hereby declared that—

(a) a Charitable Trust shall be constituted and be known as the Trusan Muslim Charitable Trust;

(b) the properties described in the First Schedule shall be administered by a Board of Trustees appointed under section 4 of the Charitable Trusts Ordinance, 1994 [*Cap. 7*];

(c) the beneficiaries of the Trusan Muslim Charitable Trust shall be the members of the Muslim community in Trusan; and

(d) the purposes of the Trusan Muslim Charitable Trust are as set out in the Second Schedule.

FIRST SCHEDULE

(Paragraph 2(b))

TRUST PROPERTIES

- (a) All funds which have been or shall be donated, collected or pledged for the Charitable Trust purposes stipulated under the Second Schedule.
- (b) Contributions, donations and gifts from any Government, Institutions, corporations and any other persons or individuals or sources for purposes of the Charitable Trust, including any legacies and properties bequeathed by will or other instruments for the Charitable Trust purposes set out under the Second Schedule.
- (c) Land, building and other properties or assets, moveable and immovable, including moneys, bonds and shares acquired or held or controlled for the purposes of the Charitable Trust.

SECOND SCHEDULE

(Paragraph 2(d))

TRUST PURPOSES

- (a) The advancement of Islamic religion and education among the Muslim community in Trusan.
- (b) The provision of assistance of any form to Majlis Islam Sarawak in pursuant to Majlis Islam Sarawak Ordinance, 2001 with the primary objective to provide maintenance and improvement of mosque and other educational buildings and infrastructures including the land for burial grounds for the said community.
- (c) Any other religious or charitable purposes which will be for the benefit of the Muslim community of Trusan.

CHARITABLE TRUSTS ORDINANCE, 1994
THE KAMPUNG BUNGIN, SPAOH MUSLIM CHARITABLE TRUST
DECLARATION, 2021
(Made under section 3)

In exercise of the powers conferred by section 3(1) of the Charitable Trusts Ordinance, 1994 [*Cap. 7*], the Yang di-Pertua Negeri has made the following Declaration:

Citation and commencement

1. This Declaration may be cited as the **Kampung Bungin, Spaoh Muslim Charitable Trust Declaration, 2021**, and shall be deemed to have come into force on the 1st day of September, 2021.

Declaration of Charitable Trust

2. It is hereby declared that—

(a) a Charitable Trust shall be constituted and be known as the Kampung Bungin, Spaoh Muslim Charitable Trust;

(b) the properties in the First Schedule shall be administered by a Board of Trustees appointed under section 4 of the Charitable Trusts Ordinance, 1994 [*Cap. 7*];

(c) the beneficiaries of the Kampung Bungin, Spaoh Muslim Charitable Trust shall be the members of the Muslim community in Kampung Bungin, Spaoh; and

(d) the purposes of the Kampung Bungin, Spaoh Muslim Charitable Trust are as set out in the Second Schedule.

FIRST SCHEDULE

(Paragraph 2(b))

TRUST PROPERTIES

- (a) Funds which have been or shall be donated, collected or pledged for the purposes specified under the Second Schedule.
- (b) Contributions, donations and gifts from any Government, Institutions, corporations and any other persons or individuals or sources including any legacies and properties bequeathed by will or other instruments for the Charitable Trust purposes set out under the Second Schedule.
- (c) Land, building and other properties or assets, movable and immovable, including moneys, bonds and shares acquired or held or controlled for the purposes specified under the Second Schedule.

SECOND SCHEDULE

(Paragraph 2(d))

TRUST PURPOSES

- (a) The advancement of Islamic religion and education among the Muslim community in Kampung Bungin, Spaoh.
- (b) The provision, maintenance and improvement of suraus and other educational buildings and infrastructures including the land for burial grounds for the said community.
- (c) Any other religious or charitable purposes which will be for the benefit of the Muslim community of Kampung Bungin, Spaoh.

TEMPORARY MEASURES FOR REDUCING THE IMPACT OF
CORONAVIRUS DISEASE 2019 (COVID-19) (HOUSING DEVELOPMENT
(CONTROL AND LICENSING)) (EXTENSION OF PERIOD) NOTIFICATION, 2021

(Made under section 6)

In exercise of the powers conferred by section 6 of the Temporary Measures for Reducing the Impact of Coronavirus Disease 2019 (Covid-19) Ordinance, 2020 [*Cap. 78*] (“the Ordinance”), the Minister charged with the responsibility for Housing Development (Control and Licensing) Ordinance, 2013 [*Cap. 69*], has made the following Notification:

Citation and Commencement

1. These Notification may be cited as the **Temporary Measures for Reducing the Impact of Coronavirus Disease 2019 (Covid-19) (Housing Development (Control And Licensing)) (Extension of Period) Notification, 2021**, and shall be deemed to come into force on the 1st day of January, 2021.

Interpretation

2. In this Notification—

“Regulations” means the Temporary Measures for Reducing the Impact of Coronavirus Disease 2019 (Covid-19) (Housing Development (Control And Licensing)) Regulations, 2021 [*Swk. L.N. 22/2021*].

Extension of Period under the Regulations

3. The period specified under regulations 3, 4, and 5 of the Regulations is hereby extended to 17th day of March, 2022.
